



Falsification of Entry Qualification:

Senate Expels 24 students ... Withdraws 7 Others

A total of twenty-four (24) students of Bayero University, Kano mostly in their final year of study were expelled from the University for the alleged falsification of their entry qualifications. Their expulsion was approved by the Senate of the University at its 374th meeting, which was held on Wednesday, 31st July, 2019.

Equally, six (6) others were withdrawn from the University for allegedly presenting fake results from their institutions while another student of B. Sc Mass Communication was withdrawn for allegedly presenting a cancelled NECO result. However, prior to their appearance before the Committee, the statement said the six students had been earlier withdrawn on poor academic performance and/or absence throughout the examinations, without cogent reasons.

A statement signed by the Director, Examinations, Admissions and Records (DEAR), Amina Umar Abdullahi, said their expulsion followed a report submitted by the Senate Committee on Entry Qualification Irregularities and deliberated upon. It categorically stated that the action of the expelled students contravenes category 3.6 and 3.8(a) of the General Examinations and Academic Regulations (GEAR) respectively.

In the same vein, eighteen students will be re-invited to appear before the Senate Committee on Entry Qualification Irregularities for fair hearing, the statement added.

A breakdown of the expelled students data indicates that Faculty of Education had the highest number of 10 and was followed by the Faculty of Social and Management Sciences with 9. The Faculties of Law, Agriculture, Science, Engineering and Arts and Islamic Studies had one candidate each.

The Committee, however, advised the management of the University to thoroughly check subsequent admissions so as not to re-admit the expelled students with such fake results into the University. It said the University was serious on ensuring quality and standards in its admission policy.

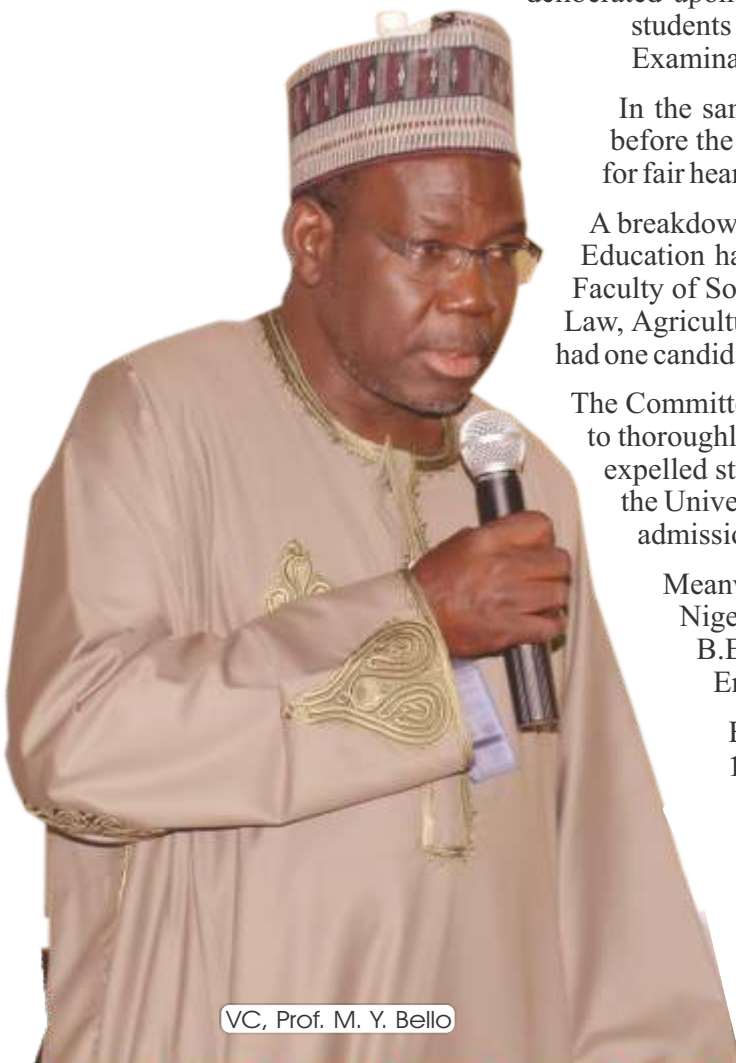

A Renowned Climate Scientist, Professor Jimmy Adegoke, from the University of Missouri, Kansas State, USA, has been appointed to serve as the Chairman of the 3rd International Scientific Advisory

Board of the Bayero University's Centre for Dryland Agriculture (CDA).

Inaugurating the Advisory Board on Tuesday, 6th August, 2019 at the Council Chamber, the Vice Chancellor, Professor Muhammad Yahuza Bello, also listed Professor L. C. Stringer (University of Leeds, UK), a globally renowned specialist on dryland

studies; Dr. Achim Dobermann (Rothamsted Research, UK), the Director- General of the oldest and the best Agricultural Research Centre in the World; Dr. Yemi Akinbamijo (the Executive Director, Forum for Agricultural Research in Africa, (FARA) and Dr. Ramadjita Tabo (the ICRISAT Director for West & Central Africa), who is a joint winner of Nobel Prize for Peace together with Al Gore and the Intergovernmental Panel on Climate Change (IPCC) as the other external members.

The internal members are the: a renowned Geographer and current DVC (Academics), Professor Adamu Idris Tanko, the Director, Laboratory Management; Dr. Ahmad Ali Yakasai, Professor J.A. Falola; Professor M.A Hussain and the Director of CDA, Professor Jibrin M. Jibrin.

The Advisory Board is to offer advice and guidance, especially on strategic matters to assist and empower the CDA to enable its operational tasks to be successfully conducted in line with the international best practices.

Speaking at the inauguration, the Vice Chancellor, who was represented by the Deputy Vice Chancellor, Administration, Professor Haruna Wakili, said in order to be a Centre of Excellence, the University

Management in its wisdom decided to form a robust Advisory Board to guide the activities of the CDA.

“The First and Second Advisory Boards of the Centre comprised of eminent personalities from varied backgrounds and expertise and chaired by a renowned Emeritus Professor, E. A Olofin. The tenure of the second board ended earlier this year and that necessitated the formation of the 3rd Board in which your distinguished personalities were carefully selected to serve for a period of two years. I am happy to note that the 10- member 3rd International Advisory Board of the CDA comprises of eminent personalities and scientists par excellence,” the Vice Chancellor stated.

In his speech, the Chairman of the Board, Professor Adegoke, said they would do everything within their powers to scale up the CDA's capacity to become a centre of excellence in dryland agriculture in Africa. He said the members were competent enough to deliver on their mandate.

The Director, CDA, Professor Jibrin, had earlier told the gathering that the Centre had come up with new vision, mission and core values. The new vision of the Centre was Resilient, Prosperous African Drylands, while the mission is to improve livelihood, resilience and sustainable use of natural resources in African drylands through training and demand - driven research.

The Director added that the new set of Core Values included good leadership and discipline; passion and team work; commitment and sacrifice; integrity and transparency; professionalism and excellence. He said these would guide the activities and conduct of the centre in moving forward.

After the inauguration, the Board inspected facilities at the CDA, including a research and commercial farm as well as the laboratories. The Board also conducted its first meeting and discussed on the CDA thematic research areas and draft strategic plans.

Step 1:

Review all your forms to ensure accuracy of all information you provided before submission. You can save your information at any time and continue with the application process at a later time.

Step 3:
