The Vice Chancellor, who was represented by the University Librarian, Dr. Musa A. Auyo, commended the alumni for their interventions and donation to the University, which he said would be judiciously utilized.

He said the University Management was willing and ready to partner with any group or individual that can contribute positively to the overall development of the University.

Earlier, the Chairman of the forum, Muhammad Dahiru Sa'ad congratulated the Vice Chancellor and his entire management team for the ranking of BUK as overall best in terms of international outlook by Times Higher Education (THE) and the 4th best in Nigeria which he described as a demonstration of determined, visionary, focused and purposeful leadership.

The Chairman who announced a donation of two million Naira to support indigent students, disclosed that the Class' 92 had adopted a 3 point approach to its activities which are to help their alma-mata and help members who are in need and also to support humanity as well as give back to the society at large.

The three-day conference themed “*Sustainable Transformation of Public & Corporate Management in the Digital Age: Perspectives, Challenges & Prospects*”, held from 10th to 12th January, 2023 at the Dangote Business School brought together scholars and stakeholders in the field of Sociology across the country, to deliberate on myriad of issues around digital transformation and of public and corporate management.

While declaring the conference open, the Vice-Chancellor, Prof. Sagir Adamu Abbas, who was represented by the

Provost, College of Natural and Pharmaceutical Sciences, Prof. Tijjani Hassan Darma commended the faculty for sustaining the conference despite many issues arising from the long closure of public universities in Nigeria and said that the theme of the conference was apt and quite relevant to the present reality.

He also stated that the digital transformation of public and corporate management is crucial in achieving sustainable development, adding that sustainable development is seen as a concept that requires meeting the needs of the present generation without compromising the ability of future generations to meet their own needs.

The Chairman of the occasion, Arc. Yusuf Zubair Kazaure and Chairman, NIGCOMSAT, while presenting his address, said that the theme would provide an avenue to discuss the pressing issues around business and governance in the age of rapid technological change.

The Dean, Faculty of Management Sciences, Prof. Kabir Tahir Hamid, in his welcome address, eulogised the Management of Bayero University, the Federal Inland Revenue Service (FIRS), Nigeria Deposit Insurance Corporation (NDIC), the Nigerian Communications

Commission (NCC), the Association of National Accountants of Nigeria (ANAN), JAIZ Bank Plc, and Dala Foods Nigeria Limited for their support in making the conference a reality, hoping that the participants would

NANS National Presidential Committee on Registration Increment Visits BUK

The National Presidential Committee on Registration of the National Association of Nigerian Students (NANS) increment paid a courtesy call on the Vice Chancellor, Professor Sagir Adamu Abbas on Monday 9th January, 2023.

The leader of the 9-man Committee, Ibrahim Ahmadu from ABU, Zaria hinted that the purpose of their visit was to meet and discuss with the management on the proposed increment of students registration fees.

The Vice Chancellor, Professor Sagir Adamu Abbas while responding to their request, welcomed the NANS representative to the University and extended his highest regards to the National President of the Association. He explained to the delegates that he was also from a humble background and also attended the same public university just like them and felt their pain because during his undergraduate years school was almost free, but now the situations are different.

He said the management was aware of the plights of the student situation most especially at this period of harsh economic situation but would do all within its power to consider them in whatever decision that would be taken because they are the engine room of the university.

Professor Abbas explained further by giving a graphic and detailed cost of running the university. According to him the money received monthly from Federal Government as overhead is far below the cost of running the University, hence the need to review the students fee.

In his breakdown, he said the University spends 45 million naira monthly to power the generator that provides electricity to the 6 campuses of the university, 32 million naira monthly to pay electricity bill, 18 million naira to outsourced cleaners, millions of naira monthly to security personnel including outsourced ones which include civil defense and police personnel. Also, 8 million naira is spent monthly to buy drugs for the clinics not to mention cost of producing examination materials. Professor Sagir said, the management would not take unilateral decision on the issue without involving the students' representatives.

He said BUK Management would not increase tuition fee but will charge fee for services such as electricity, portable water, security among others that are provided to the students. He disclosed to the delegates that the University Management is concerned with the welfare and wellbeing of the students and has provided on-campus job scheme in which 125 students are currently benefiting with a take home of 15 thousand naira monthly. He also spoke about provision of scholarship to indigent students with over 30 million naira on ground to be disbursed to students who are qualified, while also mentioning the skill acquisition centres established by the University, which will enable them acquire skills.

The DVC (Academics), Professor Muhammad Sani Gumel in his response pleaded with the students to bear with the situation. He said it is not the wish of the management to add to the sufferings of the students but rather to alleviate them because the management must source for funds to run the university, hence the reason for fee review.

Guidelines and Functions of the University Senate

1. Subject to Section 6 of the University Act an sub-section (3) and (4) of this section, and to the provision of this Act relating to the Visitor, it shall be the general function of the Senate to organize and control the teaching by the University, the Admission (where no other enactment provides to the contrary) of students and the discipline of students and to promote research at the University.
2. Without prejudice to the generality of subsection (1) of this section and subject as there mentioned, it shall in particular be the function of the Senate to make provision for:
 - a. *The establishment, organization and control of campuses, colleges, faculties, departments, schools, institute and other teaching and research units of the University and the allocation of responsibility for different branches of learning;*
 - b. *The organization and control of course of study at the University and of the examinations held in conjunction with those courses, including the appointment of examiners, both internal and external;*
 - c. *The award of degrees and other qualifications as may be prescribed in connection with examinations held as aforesaid;*
 - d. *The making of recommendations to the Council with respect to the award to any person of any honorary fellowship degree or the title of Professor Emeritus;*
 - e. *The establishment, organization and control of halls of residence and similar institutions at the University;*
 - f. *The supervision of the welfare of students at the University and the regulation of their conduct;*
- g. *The granting of fellowships, scholarships, prizes and similar awards in so far as the awards are within the control of the University; and*
- h. *Determining what description of dress shall be academic dress for the purposes of the University and regulating the use of academic dress.*
3. The Senate shall not establish any new campus, college, faculty, department, school, institute or other teaching and research units of the University or any hall of residence or similar institution at the University without the approval of the Council.
4. Subject to this Act and the statutes, the Senate may make regulations for the purpose of exercising any function conferred on it either by the foregoing provisions of this section or otherwise or for the purpose of making provision for any matter for which provisions by regulations is authorized or requires by this Act or by statute.
5. Regulations shall provide that at least one of the persons appointed as the examiners at each final or professional examination held in conjunction with any course of study at the University is not a teacher at the University but is a teacher of the branch of learning to which the course relates at some other University of high repute.
6. Subject to right of appeal to the Council from a decision of the Senate under this subsection, the Senate may deprive any person of any degree, diploma or other award of the University which has been conferred upon him if after due enquiry he is shown to have been guilty of dishonorable or scandalous conduct in gaining admission into the University or obtaining that award.

Applicants for Admission into the programmes must satisfy the following conditions:

FIVE CREDITS 'O LEVEL' RESULTS WITHOUT JAMB – (NON-UTME CANDIDATES)

- a) **Applicants with SSCE O Level results or its equivalent WITHOUT JAMB RESULTS are eligible to apply** once they have a minimum of five 'O' Level credits in relevant subjects including English at not more than two sittings.

FIVE CREDITS 'O LEVEL' RESULTS WITH JAMB – (UTME CANDIDATES)

- b) **Applicants with JAMB Results can equally apply.** Those with a minimum of **180** JAMB scores who choose Bayero University, Kano as their first choice in the regular programme will be given priority.
- c) Applicants for admission into B. Sc. Accounting, B.Sc. Business Administration, B.Sc. Mathematics, B. Sc. (Ed) Mathematics, B. Sc. Health Education and B. Sc. (Ed) Economics must also have credits in **'O' Level Mathematics.**
- d) Holders of National Board for Arabic and Islamic Studies Certificates (NBAIS) can only apply for B. A. Arabic and B. A. Islamic Studies.

DIRECT ENTRY ADMISSION

Applicants for Admission into the programmes must satisfy the following conditions:

- a) Possess a recognized Advanced Level qualification in the area relevant to the programme of choice. Such qualification(s) include(s) **National Diploma (ND), Nigeria Certificate in Education (NCE), Interim Joint Matriculation Board (IJMB) – (with a minimum of 6 points),**

Nursing Certificate, Diploma in Health Education, Diploma in Community Health, Diploma in Environmental Health, General Certificate of Education (GCE), 'A' Level and any other relevant qualification(s).

- b) Possess a minimum of **five (5) 'O' Level Credits** in relevant subjects, including English.
- c) In addition, applicants for admission into B. Sc. Accounting, B.Sc. Business Administration, B.Sc. Mathematics, B. Sc. (Ed) Mathematics and B. Sc. (Ed) Economics must also have credits in **'O' Level Mathematics**. While candidates for B. Nursing Science must have **credits in English, Mathematics, Biology, Chemistry and Physics**.
- d) Similarly, applicants for admission into B. Sc. Health Education must have **credits in English, Mathematics, Biology and any other relevant science subject(s)**.
- e) Holders of National Board for Arabic and Islamic Studies Certificates (NBAIS) can only apply for B. A. Arabic and B. A. Islamic Studies.
- f) Candidates applying for B. Sc. Public Administration should possess a credit in Government/History in addition.

APPLICATION PROCEDURE

Step - 1 An applicant **MUST** first visit **JAMB Online Application Platform for Part-Time Degree Programme**, select BUK, access the form, fill it and then make a non-refundable payment of **Three Thousand Five Hundred Naira only (N3,500:00)** into the JAMB'S Account from **Monday 2nd January 2023**.

NOTE: Applicants must fill in **New JAMB Forms** purposely meant for Part-Time Degree Programme to obtain JAMB Registration Number. **Old JAMB Forms/Registration Numbers will not be accepted.**

Step - 2 Applicant can then approach the University Portal - **www.buk.edu.ng** with effect from **Monday 2nd January 2023** and Click **PART-TIME_APPLICATION FORM** at the homepage. Login **PROGRAMME SELECTED and GENDER**.

Step - 3 User should create account at the Portal. Username and Password will be provided.

Step - 4 After you login, fill in all the necessary sections provided by the Application Portal.

Step - 5 Generate your personalized invoice. The invoice is to be printed and taken to any Bank to make a payment of Processing Fee of **Ten Thousand Naira (N10, 000:00) only. Ensure you read the Payment Procedure carefully at the Payment Procedure Page.**

Step - 6 Review your form to ensure accuracy of all information you have provided.

Step - 7 Provide your JAMB number before printing acknowledgement slip.
Remember, old JAMB numbers used for other admissions will not be accepted.

Step - 8 After completion, generate your Acknowledgement Slip. Print the Slip and keep it safe. The Slip will be needed during the collection of Admission Letter and during Registration.
